III. Reading and Approval of Minutes of the Last Meetings

- 2. Dino Sevastos then made a suggestion that the various local Wrestling Officials Associations throughout the State should consider making a donation to the Clinic to help cover some of its costs.
- 3. Dan Cutcher then made a request for those who have not turned in a history of their Association, to do so.
- 4. Dan Cutcher also brought up that Fred Feeney made a request to all present for any help that can be provided for the Sixth Annual Wrestling for Autism Tournament that is to be held in late Spring in Columbus. He also stated that Fred Feeney and the Central District had started a program called "Second Tier", to help young officials improve their skills in order to move up to do Sectional, District, State Tournaments and other major wrestling tournaments throughout the state.
- 5. Ron Tschantz then initiated a short discussion about how the District Boards pick Sectional and District Officials. A discussion was had as to possible ways to help the District Board in making those decisions.

Because of the shortness of time, and the need to get back to the Ohio State Individual Wrestling Tournament, the meeting was by unanimous vote adjourned upon Motion and Second.
